PAYMENT PLAN OPTIONS	FINANCIAL AID
<u>OPTION I: Annually:</u> Tuition is due May 20, 2024. <u>OPTION II: Semi-Annually:</u> Tuition is paid in two installments on May 20, 2024 and October 20, 2024. A \$120 administrative fee charged.	 All financial aid awards are based on financial need, as demonstrated through School and Student Services (SSS). Awarded on a first-come, first-served basis Families must apply through SSS each year.
OPTION III: Monthly: Tuition is paid in eleven monthly installments beginning in May 20, 2024 and ending in April 20, 2025. There is not a January payment since tuition deposits are due with enrollment contracts. A \$325 administrative fee is charged. With this option, you are required to participate in the Tuition Refund Protection Plan.	 Tuition Refund Protection is required for any student receiving financial aid.
